### **I. Introduction by the President**

Dear Colleagues,

With members in all corners of the globe, IPSO truly embodies an international community of psychoanalysts-in-training. From Japan to India to Kazakhstan to Honduras, from new training programs to old and established analytic societies, IPSO offers opportunities to develop and consolidate our analytic identities in the context of a broad network of like-minded people. Even with our differences in training models, theoretical orientations, training requirements, languages, and cultures, we have much in common. I recently attended the OCAL/FEPAL Congress in Santiago, Chile. Greeted warmly by our Latin American colleagues, I felt in familiar surroundings as I met candidates who were interested and deeply committed to the theory and practice of psychoanalysis.

With only seven months to go before the IPSO/IPA Congress in July, 2009 in Chicago, I would like to invite you to participate in the exciting opportunities in international psychoanalysis coming up for candidates. While the deadline for paper submissions for participation in IPSO programming will close on December 15, 2008, there are still many chances for active participation in Chicago. We are seeking candidates interested in presenting clinical material to senior analysts. This has been among the most popular of IPSO's programming for both candidates and IPA members and candidates get to present a case to a senior analyst from another IPA region. The cross-regional discussion brings an international perspective to our clinical work. We are also seeking clinical presenters for candidate to candidate clinical discussions in each of the 4 IPA languages: German, French, Spanish, and English. It is not too late to submit a paper for the Tyson award, which is given by the IPA to the best paper by a candidate. For on-going involvement in IPSO's international community, IPSO will be electing new officers in July, 2009. The following positions will be available: President-Elect; Vice President-Elect for each region (Latin America, North America and Europe), Treasurer, and Editor. IPSO's President-Elect position rotates through the three regions and this time the President-Elect will come from Latin America. The IPSO Editor should be bilingual in both Spanish and English. ## 1. Reports

There have been a few IPSO scientific events held in Europe these past few months.

Last October, our colleagues from the British Psychoanalytic Society organized an IPSO program within the English-Speaking Weekend Conference on Endings. Luisa Marino, IPSO President-Elect, attended the conference and reports:

**IPSO at the English-Speaking Weekend Conference, British Psychoanalytic Society, London, October, 12, 2008:** "It is with great pleasure that I write about the invitation to IPSO Candidates to participate in the English Speaking Weekend Conference in London on the fascinating theme of "Endings". The students' meeting was organized by SOBIPA (Students Organisation of the British Institute of Psychoanalysis) and led by Liz Allison, Anne Patterson, Alejandra Perez, and many others, at the Institute of Psychoanalysis, on Shirland Road (we luckily had beautiful warm sunny autumn weather!). The issue of Endings is even more fascinating for us candidates, since in fact we have so little experience about it...

In perfect "IPSO tradition", we started with a welcoming "sandwich lunch" before the afternoon session; we then had a clinical presentation (Megan Virtue, candidate of the BPS), during which we had the occasion of learning about many interesting and sometimes very different points of view about how we consider those "*endings of short episodes*" that may occur during the first two years of treatment. This was only one of the issues that Megan discussed during her presentation.

Mark Dagerfield then gave us his point of view and started a lively discussion amongst the audience. When my turn came, I had "live supervision" with the well known analyst Gregorio Kohon, a senior analyst who is also a writer and a poet and who was born in Argentina and who has been living in England for a long time. The diverse points of view and multicultural experiences exemplify the "IPSO spirit" and help everyone experience differences within psychoanalytic pluralism in different languages with great respect and curiosity toward the "other." I am sure this is one of many creative experiences we can enjoy during international or local IPSO meetings.

Another IPSO event took place this past October as well. Gil Son I, IPSO representative for candidates from Moscow and the Eastern European countries, organized an **IPSO event between candidates from the Moscow Psychoanalytic Society and candidates from the Finnish Psychoanalytic Society:**

"The Moscow Psychoanalytic Society (MPS), an IPA Study Group, organized on October 4, 2008 its second IPSO event. Nine candidates and two analysts from Finland came to the event. On the first night our guests went to the opera "Eugeny Onegin." On Saturday, the 4<sup>th</sup> of October, 2008, I had the pleasure of welcoming our Finnish colleagues on behalf of the MPS and of IPSO. The scientific programme started in the morning with an introduction to the history of the Russian psychoanalytic movement presented by Natalia Kigai, a member of the MPS. After this, Ksenia Korbut, a MPS candidate, presented a case to a member of the Finnish Psychoanalytic Society (FPS), Dr Levas Kovarskis. The presentation was followed by a vivid discussion of the clinical material. After a break, Jussi Kotkavirta, a candidate of the Finnish Psychoanalytic Society, introduced the "weaving thoughts" method, which was applied to the discussion of the clinical material that Hanna Maninnen, a candidate of the FPS, presented to Igor Kadyrov, member and head of the training committee of the MPS. The method proved to be successful and we indeed 'wove' fruitful thoughts in our discussion.

Afterwards we invited our guests, some of whom came to Moscow with their spouses, for a walk through the old part of Moscow. We were lucky with the weather, and the walk turned into a captivating excursion led by Alexei Orlov, a MPS candidate. We ended up in the club-restaurant "Art Garbage" ... And, at the very end, we were all invited to go to Finland! To be continued then...

**IPSO 2009 Congress in Chicago - "Conversation with Kate Schechter about the upcoming IPA Congress" by Linda Marino, Ph.D. (From the Fall/Winter 2008 issue of the *Analytic Observer*):**

Our own Kate Schechter, an advanced candidate at the Chicago Institute, is one of the four members of the Program Committee for the 46th IPA Congress. The Congress, held every two years, will be held in Chicago July 29-August 1, 2009. The Program Committee consists of one representative from each of three regions (North America, Latin America, and Europe) as well as a representative from the International Psychoanalytical Studies Organization (IPSO), which is the international candidates organization. Committee members for the Chicago Congress are Abel Fainstein from Buenos Aires, chairman; Glen Gabbard from the USA; Mónica de Armesto from Buenos Aires (ex officio); Liliane Abensour from Paris; and Kate Schechter from IPSO. As the IPSO delegate, Kate represents candidates world-wide.

In a recent conversation, Kate described the wonderful camaraderie and exchange of ideas among committee members. It has been a great experience for her to work with this group, which is at the heart of the IPA and international psychoanalysis. Members of the group have welcomed her as a fully equal member of the committee. Abel Fainstein, as chairperson, wanted the congress to have a clinical focus. Everyone on the committee is excited that the spotlight is on clinical material and practice issues rather than on theoretical papers. What happens in the consulting room will be front and center in the program. Many of the panels will consist of one person giving clinical material to be followed by people from different regions, schools, and cultures of psychoanalysis giving their diverse perspectives on the clinical issues raised. The committee is working hard to balance all of the panels with members from each region, insuring that the Congress will be a real forum for cross-cultural dialogue.

It is exciting to have the most important meeting in the international psychoanalytic world right here in Chicago. The Congress will be a great opportunity for us to learn about psychoanalysis in the rest of the world. Kate has just returned from a recent meeting of the Program Committee in Buenos Aires, where she was excited to learn more about the Argentinean schools of psychoanalysis. She shared with me the interesting fact that Buenos Aires has more psychoanalysts per capita than anywhere else. The Congress is expecting a very large turnout of analysts from the USA. In fact, APsA has cancelled its 2009 spring meeting to encourage everyone to attend the IPA Congress instead. The LAC (Local Arrangements Committee), headed by Jorge Schneider, has been busy organizing events, activities, transportation, and other logistics to welcome the attendees and to make Chicago accessible for their enjoyment. Everyone in the field who would like to attend is welcome; categories for attendance include IPA members, non-members, candidates, and students. A second exciting event that is separate from but adjoined to the IPA Congress will be the 20th IPSO Congress, which will be held on the day preceding the IPA Congress, (July 28), with several panels running concurrently with the IPA Congress as well. All of the panels in the IPSO Congress feature candidates presenting their own work. The IPSO Congress will also include supervision sessions, "Meet the Author" and "Meet the Analyst" sessions, all great opportunities for candidates to present their work to senior analysts from other regions, as well as to learn from each other about the different analytic training traditions. All candidates are encouraged to submit an abstract for a paper. One of the events that is eagerly anticipated by regular attendees of IPA meetings is the famous IPSO party, which is widely known for its emphasis on international music, good food, lots of dancing, and much fun. Jeffrey Seiden, the Chicago Institute's Candidate representative on the LAC committee, is also the chair of the Candidate LAC for IPSO. He and his committee are planning a slew of wonderful activities for candidates, including the IPSO party, an IPSO lunch, and lots of other fun Chicago outings. 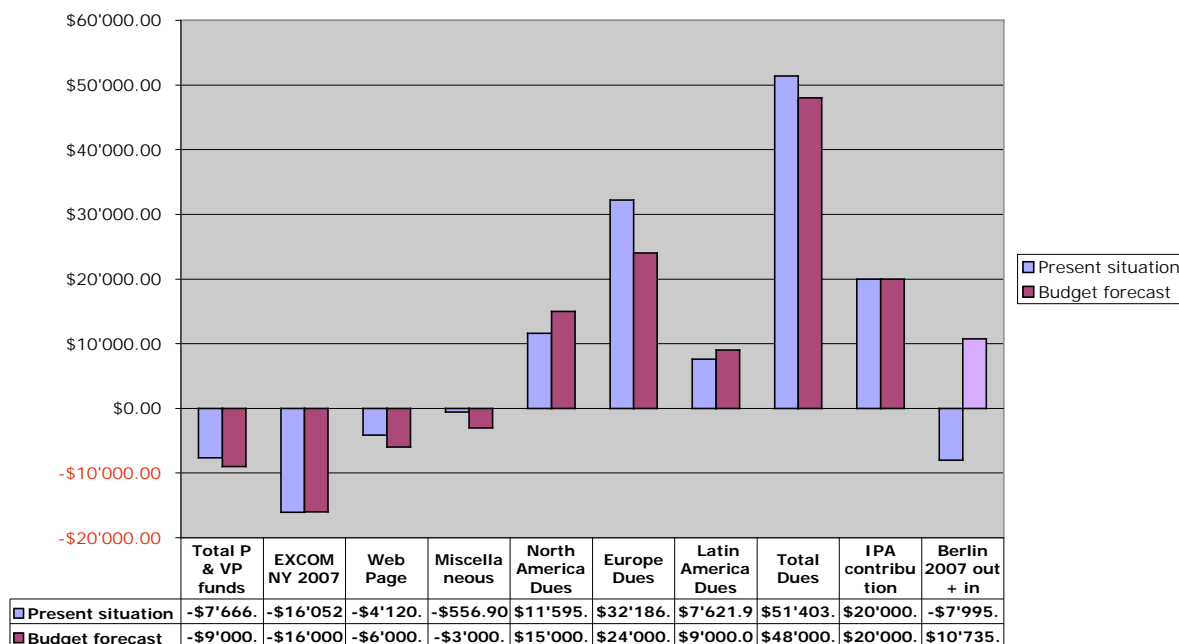
#### **IV. Treasurer's Report**

Dear Colleagues,

It's dues collection time! For the first time in IPSO history, candidate groups are being billed on an annual basis for IPSO dues. Each candidate group is asked to provide the names and email addresses of IPSO members at the time that dues are paid. Dues reminders will be billed in December 2008 for 2009 membership and are due no later than March 31, 2009. IPSO is working to allow IPSO members to use their credit cards to pay directly for their membership dues.

IPSO has also moved to a two year budget projection. At this moment, income projection is difficult since we do not know how much we will collect in dues. However, as we develop a system where dues are routinely billed and collected, we expect dues collection to become more predictable. Expenses will increase in 2009 as we pay for major expenses associated with the Chicago Congress: costs of simultaneous interpretation (approximately US \$20,000); lunch for IPSO members at Tuesday's IPSO Plenary (approximately US \$4000); the Journal to be published at the Congress (approximately US \$2000), and services for the Congress (approximately US \$16,000). A more detailed budget will be available for IPSO members at the Business meeting in Chicago.

### Budget 2008



- Total President and Vice President Funds – expenses for required IPSO meetings that President and Vice Presidents have to attend: European Psychoanalytical Federation, IPSO meeting, OCAL meeting.
- Excom NY - Excom annual meeting in New York in January.
- WebPage - reestablishing, updating and management of IPSO Website.
- North American dues are less than expected (we are waiting for the dues from the independent societies.)
- European dues in 2008 have been higher than our projections based on previous experience.
- Latin America dues are less than expected based on previous projections.
- Total dues are slightly higher than expected.
- IPA contribution - IPSO receives a grant of \$10000 per year from the IPA. Current budget reflects two years payment since both 2007 and 2008 were paid in 2008.
- Berlin 2007 - final bills and benefits of the Congress: it does not show how much the Congress cost IPSO. Most of it was charged during the 2007 budget.

### **VI - Communication Officer Report**

**Database of IPSO members** - It is our current policy that IPSO membership benefits are available only to candidates who are paying IPSO members. To that end we have been collecting the lists of IPSO members that IPSO Representatives send us in order to create our own Database.

On the other hand every year the IPA receives the lists of candidates from the several societies. It's the crossing of both the data obtained by us and the data obtained by the IPA that allows the creation of an IPSO ROSTER.

In the beginning of December 2008 the figures on the IPSO ROSTER are:

Europe – 356  
Latin America – 283  
North America – 718  
Total - 1357 (i.e. roughly 38% of all IPA candidates)

There is a considerable difference between the number of European IPSO Members according to IPSO's own Database and the IPSO ROSTER. In fact IPSO has more than 800 IPSO members in Europe. This higher number cannot be considered for the IPSO ROSTER because the societies to which those members belong are not willing to send the IPA their lists of candidates. This has been the case of France (SPP), Italy (SPI) and Israel which, among them, have more than 500 IPSO members.
